

No. CBR/ DA VC/83/2867 dated 9.6.1983 on the subject cited above, I am desired to inform you that the recommendations made by the Inspection Committee for starting the newly proposed College by your Society/Management, has been considered by the Executive Council of this University in its meeting held on 30.8.198' the Inspection Report hasbeen accepted/approved vide its Resolution and consequently has granted Frevisional Affiliation/recognition to D.A.V. College, Cheeka (Kurukshetra) to start the Arts & Commerce faculties i.e. Prep Arts & B.A. Part-I with the introduction of English, Hindi, Sanskrit, Punjabi, Civics/Pelitical Science, Economics, Mathematics & History and Prep (Commerce) & B. Com. Part-I classes w.e.f. the academic session 1983-84, in the first instance, subject to the fulfilment of the fellowing condition The Cellege Management must appoint the below noted teaching & non-teaching staff after adopting the proper procedure prescribed 1. for the purpose:-One Lecturer is each/of the Subjects of Hindi, Sanskrit, Punjat Principal . Science/Civics, Economics, Mathematics, History & Commerce **ii**) 111) Besides the above staff, the Management must arrange (a) the appointment of an Instructor in Stene-typing; (b) One Typing Room Attendant; (c) One D.P.E.; (d) One Librarian & other non-teaching states teaching staff, as per University norms. Two Lecturers are to be appointed to cope with the work-load in English and to be appointed to cope with the work-load
