Dear Sir,

Please refer to your letters No.845-846 dated 15.12.2012 on the subject cited above.

In this connection, it is to inform you that the following preliminary conditions are required to fulfill for the introduction of these course :-

1. No Objection Certificate of the State Govt. to introduce M.Com. course from the session 2013-14.
2. Resolution of the Governing Body of the college for regarding introduction of M.Com. course on self financing basis from the session 2013-14.
3. Undertaking from the President/General Secretary of the College to the effect that the college shall abide by all the rules and regulations of the University/State Govt. or instructions issued by them from time to time and shall incur all the expenditure on this account from its own resources.
4. Application fee of Rs. 10,000/- for M.Com. course through bank draft drawn in favour of the Registrar, Kurukshetra University, Kurukshetra payable at Kurukshetra.
5. 25% Late Application Fee of Rs. 2500/- (upto 31st January, 2013) through bank draft drawn in favour of the Registrar, Kurukshetra University, Kurukshetra payable at Kurukshetra.

It is also made clear that the college shall not start any subject/course at its own level even if the State Govt. has accorded sanction for the purpose w.e.f. a particular academic session, anticipating affiliation from the University. The classes for such course/subject shall be started only after the affiliation is granted by the University.

You are requested to submit the above documents/information immediately to enable this office to process the case accordingly.

Provisional No Objection Certificate is hereby granted to start the below mentioned
subject/course/extra seats in your institute from the academic session 2013-2014 on the following
conditions:-

New Course

- M.Com

1. No financial assistance/grant in any form at any stage will be given by the State Government. The institution will have to bear all the recurring and non-recurring expenditure of the classes for all times to come. The building intended for educational occupancy will not be used for any hazardous occupancy.
2. The institution will seek affiliation from the University for the course (and send a copy to this office) and shall follow all other conditions imposed by the affiliating University/University Grants Commission and Government.
3. The institution will follow all the guidelines of the University Grants Commission/affiliating University in the matter of recruitment of staff and staff strength.
4. The institution will appoint qualified lecturer (s) in required number as per norms and submit report to this effect to Government. The institute shall also submit a detailed report regarding the number of students enrolled in the class for which the NOC is issued after the commencement of the academic session.
5. In the admission of the students, there shall be reservation of seats for SC/ BC/OBC, Handicapped, ex-servicemen, Sports Persons, Freedom-Fighters and any other reserved category as per the State Government Policy.
6. No discrimination on the basis of caste/creed/colour/sex/religion shall be made while recruiting the faculty.
7. The Government can impose any other conditions (s) at any time which shall be binding on the College Management.
8. Any contravention of the above stated conditions shall result in withdrawal of "No Objection Certificate" and legal action against the defaulting society/ institution.
